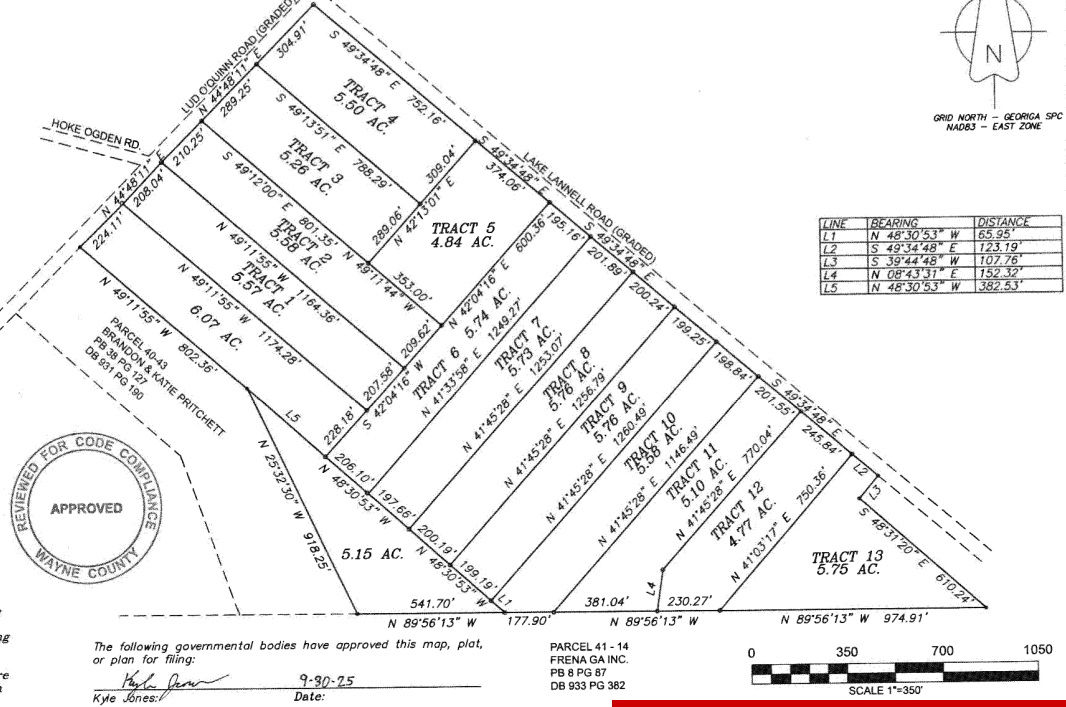

Field Precision: This entire survey was completed using GPS Base and Rover, Real Time Kinematic, surveying methods using multi-frequency receivers. The field data for this boundary survey has a Relative Positional Accuracy of 0.05 feet or less, horizontally at the 95% confidence level.

SURVEY NOTES:
1. Horizontal Datum is Georgia State Plane Coordinate System of 1985, East Zone, North America Datum of 1983 (NAD83).
2. Basis of Bearings and Horizontal Control were obtained utilizing GPS (global positioning systems). The equipment used to obtain this data was a Carlson BRX7 GNSS receiver [RTK Accuracy (Horizontal: 8mm + 1ppm RMS) (Vertical: 15mm + 1ppm RMS)] with a Carlson RT4 data collector receiving RTK corrections via Verizon Network from the eOPS Solutions Real Time Network.
3. All deed book references shown herein are recorded in the Clerk of Superior Court's Office of Wayne County, Georgia.
4. This survey was prepared without the benefit of an abstract of title. Subject and adjacent property owners' deed references were provided by Everett Tomberlin and Associates and are not guaranteed as to accuracy or completeness.
5. The equipment used in obtaining the linear and angular measurements used in the preparation of this plat was: Carlson BRX 7 Base and Rover, and Carlson RT4 Data Collector.
